- Packages are LIMITED AND ARE AVAILABLE ON A 'FIRST COME / FIRST SERVED' BASE
- Tour operators **DO NOT SELL ONLY ENTRIES.** Entries must be sold as part of a Travel Package.
- Entries for the Abbott Dash to the Finish Line 5km race are available at €50 cost. Slots are limited!
- DEPOSIT must be paid <u>latest 3 days after application</u>
- We approve payment in installments; last payment should be made until 01.09.2024.
- In case of non-payment of due installment, the agency will consider that client have canceled the arrangement
- All types of rooms are subject to availability
- For international payments, bank fee should be covered by Sender only
- Extended stay is possible upon prior request
- For **individual / single registrations**, Traveler can book only single room (1 bed private room). Other types of rooms are available only for Travelers who applying together.
- The application of the Traveler shall become valid from the moment of its confirmation by conclusion of a Contract according to the application and advance deposit payment
- All types of changes are possible ONLY until 08.09.2024, no exeptions.
- Cancellations are subject to agency's and program's terms and conditions
- INVITATION FOR REGISTRATION will be sent out to each runner, during spring
- **CONFIRMATION FORM** runners can expect to receive approx. 3-4 weeks before the marathon.

1.day (31.10.2024.) - Individual arrive in chosen hotel in New York City (Manhattan). Check-in from 3:00pm. Free time. Overnight.

2.day (01.11.2024.) - Breakfast. Group gathering with participants in morning hours. Free time for individual activities and New York City sightseeing. Individual pickup of the start numbers at the Expo. Parade of Nations and Opening Ceremony in Central Park. Overnight.

3.day (02.11.2024.) - Breakfast. 5km race *Dash to the Finish Line*, in Central Park. Free time for individual activities and New York City sightseeing.Pasta dinner for all our guests. Overnight.
4.day (03.11.2024.) - Early breakfast. Going to the bus transfer (location: Public library).Arrival at the start zone on Staten Island. Participation in the marathon race - first start is at 08:00am. Individual return to the hotel. Free time for individual activities. Celebration dinner for all our guests. Overnight.
5. day (04.11.2024.) - Breakfast. Check-out from hotel until 11:00am/12:00pm. End of program

<u>HOW TO APPLY</u>

- Download the application form here: <u>http://marathon-travels.com/en/application/</u>, fill it electronically and send it to our email address, in WORD or PDF.
- > When we receive your application, we will send you the payment instructions.
- > After we receive deposit payment we will send you a *Travel Contract*, in due course.
- Client is obligated to sign the travel contract and send us back on our email.

Supporters should fill the same application form, without filling details related only to the runners. It is MANDATORY that all passengers fill out the application form.

If for any reason the passenger does not send a signed agreement, the confirmation of receipt of the email with the agreement or the payment of the deposit for the arrangement will certainly be considered as confirmation of all the mentioned points from the travel agreement.

By signing up for the program, the traveler confirms that he/she has received, read and understood the Agency's General Terms and Conditions, as well as the travel program itself, and that he/she fully accepts them.

INDIVIDUAL APPLICATIONS

For travelers applying individually, the available option is 1/1 private room. We can combine passengers for 1/2 room, only if another passenger is interested in sharing. We do not combine passengers for 1/3 and 1/4 rooms. 1/3 and 1/4 rooms are intended for travelers traveling and checking in together. In case two or more passengers make a booking together and after signing the agreement one of them withdraws from the arrangement for any reason whatsoever, they will be jointly and severally liable for the expenses in accordance with the terms and conditions of the Travel agreement. The organizer has the right to charge the full price of the accommodation unit.

• HYATT HOTEL Harald Square 4* - Midtown, Manhattan

The hotel is located in the heart of Manhattan, just two blocks from the Empire State Building and Madison Square Garden, and just a few steps from the famous 5th Avenue. Central Park, where the marathon finish line is, can be reached in just 15 minutes on foot, while Bryant Park, where the bus transfer to the start of the marathon departs, can be reached in just a few minutes. Wi-Fi, restaurant, bar, fitness center, roof terrace, Grab&go market, room service are available to guests. The rooms consist of a TV, hair dryer, air conditioning, iron, tea/coffee maker, refrigerator, soundproofing, etc.

* In case of unexpected and reasonable circumstances, Organizer reserve the rights to change acoommodatin unit without the Traveller's consent for accommodation in facilities of the same or higher category in the agreed location of the facility at the expense of the Organizer, while accommodation in lower-category facilities may be substituted only with the consent of the Traveller and with a refund of the difference in price in relation to the lowered category of the accommodation facility.

REPLACEMENT OF PASSENGERS

The conditions related to the exchange of passengers are defined separately for each trip and depend on the conditions agreed with each of the organizers of the sports event. The passenger has the right to designate another person to travel instead of him, with the right of the organizer to claim the costs incurred by changing the passenger. The passenger and the person who takes his place are jointly and severally liable for the payment of the agreed price and replacement costs. The organizer will not accept the replacement of passengers if the change is not timely, if there are special requirements in relation to the trip or if it is not in accordance with the law or other legal regulations.

The passenger (runner) can find a replacement no later than 08.09.2024, with the payment of replacement costs in the amount of \in 50. Replacement of runners after this date, according to the conditions of the organizers, is absolutely not possible. Changing the escort is possible up to 15 days before the start of the trip, free of charge.The Organizer, if the Traveler provides a suitable replacement, is obliged to refund the paid funds to the Traveler in the total amount, after deducting only actual and incurred costs, a minimum of 5% for administrative costs + \in 50 for replacement costs. If, on the other hand, the Travel Organizer finds a replacement passenger in the amount of 15% of the agreed amount of the arrangement + \in 50 for the replacement costs.

PAYMENT CONDITIONS

The application of the Traveler shall become valid from the moment of its confirmation by conclusion of a Contract according to the application and advance payment of 40% of the package price. Deposit must be paid latest 3 days after receiving payment instructions/invoice. Deposit is non-refundable. The remaining 35% shall be paid latest until 01.June 2024, and the balance (25%) of the agreed price latest until 01. September 2024, unless otherwise arranged. Clients should cover all bank fees. Agency must receive agreed amount in full, without any deductions.

The displayed prices are valid for payments of the entire amount at once. For payment in installments, the price of the arrangement is not increased. In case the payment is not registered within the stipulated payment period, the passenger will be contacted via email address. The passenger will not be contacted in order to inform about each individually received payment. In case of non-payment of due installment, the agency will consider that client have canceled the arrangement.

If payment is made from abroad, the client is obligated to cover the bank fees (and intermediary bank fees) in <u>full</u>. The travel organizer must receive the exact agreed amount, otherwise the client will be obligated to compensate for the difference. If for any reason the traveler does not cover the difference, the Organizer has the right to reject that application or terminate the travel agreement.

Protection of data privacy:

To successfully process your request we need your personal data. In our name, we are committed to protect the privacy of all our customers. We collect only the necessary, basic information about customers and information necessary for operations and to provide quality services. All customer data is strictly confidential and are available only to employees who need the information to perform their duties. All employees of the travel agency Active Traveling are responsible for respecting the privacy protection principles. We commit ourselves that all collected information will not be used for other purposes, nor passed on to third parties.

IMPORTANT NOTES ABOUT HOTELS

- It could be obligate leaving the deposit - cash or with a credit card, to cover incidental charges to your room. The policy ensures that if a customer leaves without paying for room service, phone calls, pay-per-view movies or minibar items, the hotel will be covered, at least in part. We recommend use of c.card.

- Any type of loss or damage to items in the room or any public space will result in a charge that will be at the discretion of management.

- Check-in Time: 03:00pm, Check-out Time: 11:00am. Any use of rooms before/after check-in and check-out, cause extra charge.

- Description of hotels is for informational purposes only. For some deviations travel agency doesn't has responsibility, because it depends on hotel.

- Use of some extra facilities on the hotel could be extra charge

CONDITIONS OF TRAVEL CANCELLATION BY THE PASSENGER

If the traveler cancels the trip in the meantime, he/she is obliged to compensate the organizer for the incurred costs. **The traveler has the right to cancel the trip**, about which he is obliged to inform the Organizer in writing in the manner in which the Agreement was concluded. The date of written cancellation shall serve as the basis for calculation of compensation duethe Organizer, expressed in a percentage of the total cost of travel, which is determined in the Program, namely: Runners: 20% if the trip is canceled until 30.04.2024; 30% from 01.05. - 30.06.2024; 50% from 01.07.- 31.07.2024; 80% from 01.08.- 19.08.2024; 90% from 20.08.- 08.09.2024; 100% after 08.09.2024, in case of no-show or during the trip. Supporters: 10% if the trip is canceled until 30.06.2024; 30% from 01.07.- 31.07.2024; 50% from 01.08.- 30.08.2024; 70% from 01.09.- 30.09.2024; 100% after 30.09.2024; in case of no-show or during the trip. Client will receive a *cancellation form* by email, which he/she must filled out and sign.

- In case of shared room, which was requested by clients in person, if any of clients cancel the trip, cancelation
 penalty percentage will be subject of cost estimation in current moment. Room can not be canceled if only one
 runner/passanger cancel arrangment.
- Entry fee for the marathon is not possible to defer to the next year.

- CANCELLATION OF TRAVEL IN CASE OF FORCE MAJEURE before the start of the trip for which neither party is responsible In case of cancellation of travel due to force majeure (earthquakes, floods and other natural disasters, epidemics, pandemics, wars, terrorist attacks, etc.) or inability to leave/enter the destination country, for any reason which could not be affected or avoided by Travel Organizer despite due care and responsibility, the Travel Organizer is obliged to refund the passenger, reduced by the amount of actual costs and exchange rate differences, up to 5% for administrative costs, and the determined percentage on behalf of agency services, namely: 10% for cancellations before until 08.09.2024; 20% for cancellations after 08.09.2024.
- CANCELLATION OF THE JOURNEY DUE TO CANCELLATION OF THE RACE BY THE ORGANIZER OF THE MARATHON - Since the registration fee for the race is the most important element of the travel contract, in case the sporting event is canceled by the organizer of the marathon, which would make the realization of the trip impossible, **the conditions offered by the marathon organizer will apply**, whereby the Travel Organizer is obliged to refund the passenger, reduced by the amount of actual costs and exchange rate differences, up to 5% for administrative costs, and the determined percentage on behalf of agency services, namely: 10% for cancellations until 10.09.2023; 20% for cancellations after 10.09.2023.

OTHER IMPORTANT NOTES

- The agency is not responsible for any information given orally or by phone. ONLY THE WRITTEN TRAVEL PROGRAM IS VALID.
- Each participant has to take care about valid visa on his/her own. Travelers must have a valid passport with enough blank pages and that it's valid for at least 6 months after their stay. Visa or visa issuing supports are not included in our travel packages. We suggest clients to obtain a visa before committing to travel arrangements. The travel organizer doesn't have responsibility in case of visa rejection.
- Passengers from abroad can provide "Insurance against the cancellation of the arrangement" only in their own country, and only on the day of concluding the contract.
- Agency will not tolerate "time wasting". If clien applies for the trip, and we answer all his/her questions and send
 payment instructions together with an invoice, and at the end client do not make payment and do not inform us about
 the cancellation, we will not him/her allow to apply to any other of our trips in the future.
- In case of changes in the conditions of third parties (marathon organizers, hotels) regarding protection measures against the covid19 virus, the Tour Operator will not be liable if the traveler does not meet the required conditions.
- We may provide you with information (before departure and/or when you are on tour) about activities and excursions which are available in the area you are visiting. We have no involvement in any such activities or excursions which are neither run, supervised, controlled nor endorsed in any way by us. They are provided by local operators or other third parties who are entirely independent of us. They do not form any part of your contract with us even where we suggest particular operators/other third parties and/or assist you in booking such activities or excursions in any way.
- The travel agency keep possibility to change itinerary due to unpredictable and objective conditions. All passengers
 are obligate to respect all custume duties.
- All conditions in the travel program, related to payments and cancellation deadlines, are harmonized with the conditions of the marathon organizers, as well as with the conditions of the contracted hotels.
- All final information and details about the trip, clients will receive up to latest 3 days before the trip.
- Date of formation of the travel program: 31.01.2024.
